Old Business:

• Update on 2023 Budget

Summary	Brady informed the Board that there was an error in the 2023	
	budget. The increase in property tax projected on the original	
	draft of the budget was incorrect and will not occur until 2024.	
	With this decrease in revenues a number of line items have been	
	removed from the expense section of the budget. The items that	
	were left intact were the employee wellness benefit to include	
	Health Screening and Ski/Rec Passes. There was discussion of	
	the Wildland Coordinator's salary and possible housing subsidy,	
	relating to the housing crisis in the District. Prescribed Burns	
	will be an anticipated addition although not included as a line	
	item at this time.

• Open Bank Accounts at Yampa Valley Bank

Summary	Yampa Valley Bank has agreed to a Line of Credit on the revenues generated by the Personnel of the Deployments of 2022 which have not been paid out by the State of Colorado. In order to pay the Firefighters that were on deployment, a line of credit was needed. One of the stipulations of this LOC was that the District move their banking services to YVB.

• Other Discussion

Chief Glauthier and the Board discussed the possibility of subsidizing Lt Hohnbaum's housing in Oak Creek in order to place an Officer in town. Lt. Hohnbaum would be available to respond to calls and would rotate this responsibility with the Chief. This should create a positive step in decreasing the	
response time within the Town of Oak Creek calls. Reservist Pay: Reservist that respond to a call for the District will receive a stipend for their service, rather than an hourly pay. This will keep them in a Reservist status and not an employee status. This stipend will be \$50 per call out. This is effective immediately.
